Document processing is available **Monday to Friday between 9.00 am and 5.00 pm**, or on **weekends** by prior arrangement.

The set-up process is easy with **FREE registration** and no hidden administrative charges.

The time difference between Eastern and Western Standard Time provides the opportunity for **extended hours services to our East Coast** based exporters.

Charges vary depending on document type and membership status. Invoicing is available **monthly or per certificate** and payable via **EFTPOS, credit card or bank transfer**.

**Member rates range from \$35.00 - \$38.00** per certificate pack. Non-member rates range from \$66.00 per certificate pack, or \$72.00 for other documents. Replacement certificates are available from \$23.00 - \$35.00.
