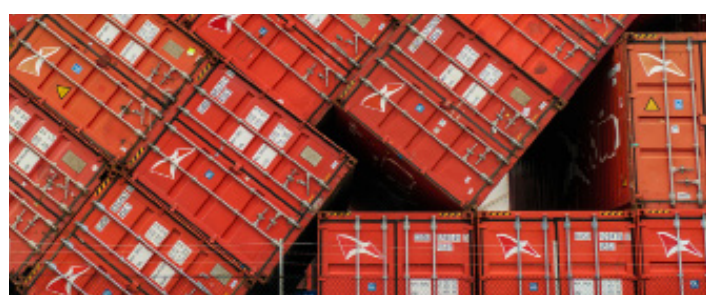
## Networking & Events
